On March 21, 2017 at approximately 1507 hours, reporter/victim [REDACTED] the Edgewood Police Department. She wished to report abuse that occurred to her by suspect Augustus Sol Invictus, date of birth 07-31-83. (A.K.A. Austin Gillespie)

[REDACTED] stated that she had resided previously with her now ex-boyfriend Mr. Invictus at 548 Orange Drive, Altamonte Springs, Florida. [REDACTED] advised me that over the course of a fifteen month period, between November 2015 and January 2017, while residing together as a couple, Mr. Invictus battered and abused her on several occasions to include false imprisonment and aggravated assault with a firearm. These incidents included smashing her head into the center console of a vehicle, pushing her out of a moving vehicle, punching her, kicking her, choking her until she would pass out, throwing her across a room and dragging her.

[REDACTED] described a time period when Mr. Invictus held [REDACTED] captive at their place of residence from March 21-26, 2016 until her bruises healed. [REDACTED] also described a time when Mr. Invictus got angry, beat her until her eyes were swollen shut, dragged her into the closet and put a gun to her head, asking her why he shouldn't kill her. Then he went on to say he would kill her right then, make her disappear, then go "off the grid" or kill himself. A similar incident happened again in January/February 2017 where he dragged her into the closet and put a gun to her head, beat her and attempted to suffocate. This went on for several hours. [REDACTED] explained that he then

proceeded to sexually assault her. She explained that when he was finished he said "That's what you wanted, right? Fucking whore."

She left after that but recently, on March 16, 2017 she was on her laptop and pulled up a Google Calendar which was from his email account. It had a lay out of the month of March, and on March 17, 2017 it read "Annihilate [REDACTED]" in all red letters. [REDACTED] explained to me that nothing happened to her on that date and he had no known contact with her on that day. She then advised me that on March 18, 2017 her parents received a text from a number they did not recognize. It mentioned something about [REDACTED]'s Sex Show and a link. [REDACTED] has suspicions that this was from Mr. Invictus.

[REDACTED] expressed to me that she does not feel safe, even though she has moved out and is now living with her parents. She explained to me that Mr. Invictus is a "high-powered" attorney, has ties to white supremacist individuals, and knows everything about her, including where she is living now, her friends and family contact information, and her place of work. [REDACTED] stated that he has threatened them all in the past.

I asked her why she never reported any of this to law enforcement or others, and she explained to me that he threatened that if she ever said anything to anyone he would hurt her family and friends. [REDACTED] appeared meek and scared and I believe its possible he had mental power over her during their relationship.

I advised her to seek an injunction immediately against him through the Orange County Courthouse. I explained the documentation she would need and gave her copies of her statement and my business card with case number.

I also explained that she needs to report these crimes to the Altamonte Police Department immediately, and contact us is she sees him in the city and feels threatened.

She provided a written sworn statement which included suspect Mr. Invictus's information. (attached)

This is an information report only since no crime occurred in this jurisdiction.
