STANDING RULES

I. Conduct Within the Meeting Room

1. Except for those devices necessary for the conduct of the business meeting by the Board and Convention Committees and Officials, all electronic devices shall be silenced at all times while in the meeting room.
2. For admission to the Delegate seating area while the business meeting is in session, Delegates shall be required to wear the badge issued by the Credentials Committee upon registration.
3. Only Board Members, Convention Committee Members and Convention Officials shall sit at or stand behind the tables at the front of the Delegate seating area.
4. No person shall disturb materials placed on a Delegate seat, except for the Delegate occupying the seat.

II. Organization of the Convention

1. The State Chair shall conduct the official organization of the Convention promptly at the time published in the Convention Schedule. The official organization shall proceed as follows:
 - (a) The Credentials Committee shall report the number and the names of all Delegates registered as present with proper credentials. The list of the names of the Delegates shall be posted or projected in lieu of being read, and the Delegates shall be afforded time to verify the completeness and accuracy of the list, whereupon the report shall be adopted by majority vote. Quorum shall be fixed at the next whole number greater than exactly half of the number reported by the Credentials Committee.
 - (b) The Committee on Standing Rules shall report on the rules of the convention, which shall be adopted by two-thirds vote.
 - (c) The Program Committee shall report on the agenda, which shall be adopted by majority vote.
2. The State Chair shall serve as the Convention Chair and, immediately upon concluding the official organization, shall appoint three Delegates to the Resolutions Committee and shall appoint Convention Officials which shall include Recording Secretary, Parliamentarian, Projectionist, Audio Technician, Sergeant-At-Arms and Assistant Sergeants-At-Arms.

III. Reports, Resolutions, and Announcements

1. Acceptable electronic formats shall include ASCII text (.txt), Comma Separated Values (.csv), Graphics Interchange Format (.gif), Hyper-Text Markup Language (.htm, .html, or .xhtml), Joint Photographic Experts Group (.jpe .jpeg or .jpg), Microsoft Excel 1997 or later (.xls or .xlsx), Microsoft PowerPoint 1997 or later (.ppt or .pptx), Microsoft Word 1997 or later (.doc or .docx), Open Office 2.0 or later (.ods or .odt), Portable Document Format (.pdf), Portable Network Graphics (.png), Rich Text Format (.rtf), Scalable Vector Graphics (.svg), and Extensible Markup Language (.xml).
2. All reports and other material for the permanent record or printed proceedings shall be in an acceptable electronic format and shall be sent to the Projectionist and the Recording Secretary prior to presentation.
3. A resolution offered by an individual Delegate shall be in an acceptable electronic format or legibly printed and signed by the maker and the seconder and shall be sent directly to the table of the Resolutions Committee.
4. Resolutions shall be handled by the Resolutions Committee as follows:
 - (a) All resolutions, except those proposed by the Board of Directors or by committees, and any recommendations made in reports of officers or committees of the convention that are not in the form of resolutions shall be referred without debate to the Resolutions Committee; resolutions proposed by the Board of Directors or by committees shall be presented by the Board or proposing committee directly to the Delegates. Amendments may be offered verbally, but the Chair or the Delegates may refer them to the Resolutions Committee if they become overly involved.
 - (b) Each Delegate who offers a resolution shall be given an opportunity to explain it to the Resolutions Committee if he

so requests.

- (c) The Resolutions Committee shall prepare suitable resolutions to carry into effect recommendations referred to it, and shall submit to the convention, with the Committee's own recommendation as to appropriate action, these and all other resolutions referred to the Committee, except questions which the Committee by a vote of two thirds of its members may decide not to report.
 - (d) The convention by a majority vote may suspend this Rule 4 and may immediately consider a question, or may order the Resolutions Committee to report a question at a certain time, even if the Committee has voted not to report it.
5. Notices for announcement to the convention shall be in an acceptable electronic format or legibly printed and signed by the person (or a proper representative of the persons) under whose authority the announcement is issued, and shall be sent to the desk of the Recording Secretary.

IV. Conduct of Debate

- 1. The Convention Chair shall regulate the proceedings at all times so as not to outpace the Recording Secretary or Projectionist.
- 2. No Delegate shall speak except upon recognition by the Convention Chair when standing at the floor microphone.
- 3. No Delegate shall speak in debate more than once on the same question on the same day, or longer than two minutes, without permission of the convention granted by a simple majority vote without debate.
- 4. A Delegate shall not substantially repeat what another Delegate has already said on the same motion. The Convention Chair shall warn a Delegate once, and shall revoke any remaining time upon the second offense.

V. Nominations and Balloting

- 1. The Campaigns Director shall include in his report the list of public offices for which there are multiple contenders and the list of public offices for which there are single contenders. The Convention Chair shall conduct the nominations in the order they appear in the Campaigns Director's report, followed by open nominations for other public offices.
- 2. For each public office for which there are multiple contenders, the total duration of candidate and nominating speeches for an individual contender shall be no longer than two minutes. A separate ballot for each office shall be projected and circulated to the Delegates, and the results of the balloting shall be announced before the next office is considered.
- 3. For each public office for which there is a single contender, the Convention Chair shall read and cause to be projected the contender's name, after which the Convention Chair shall call for any additional nominations for those offices. Additional nominations shall be added to the projected ballot and written in by the Delegates on the ballots they receive, and two minutes shall be allotted for speeches for each contender for only those offices that have become multiply contested. Single contenders are encouraged to sign up for time during the scheduled speaking periods. Voting shall proceed as prescribed above.

VI. Parliamentary Authority

- 1. The rules contained within Robert's Rules of Order Newly Revised 10th Edition shall govern the Convention in all cases to which they are applicable and in which they are not inconsistent with the Constitution and Bylaws of the LPCO, these Convention Rules, and any special rules of order the Convention may adopt.

Shnelvar questioned the mechanics of the quorum count.

Business continued with nominations.

Returned to orders of business: National Delegate Selection

Orrok announced that we've been allocated 28 delegates. He pointed out that more national memberships earn us more delegates. He called for volunteers for the June 26th convention in Columbus, Ohio.

Norm Olsen made a motion to delegate authority to appoint delegates to the board. This was seconded by Bill Robinson. Olsen described the process to become a national officer. The motion was adopted without objection.

Sarwark moved that we vote for the delegates as a slate. The motion was seconded and adopted without objection. The delegates were approved unanimously.

Bill Robinson moved that the board report displayed in the convention program be approved as printed. This was seconded and adopted unanimously.



Orrok shared the good news of the amazing growth of the Libertarian Party of Colorado. The number of registered Libertarians has been doubling every 4 years. Currently we are growing at 11%, faster than any other party. He encouraged everyone to participate in growing the party. He mentioned that Evan McMahon is part of a national group that is working with 5 counties in Colorado to grow even faster.

Orrok acknowledged everyone who helped on the recall election and especially Jan Brooks for her run for that office.

Eva Kosinski: “To spur greater interest in attending and participating in the State LP Convention, I propose that the board set aside 3 all access convention places to be given to students who apply. A drawing will be held a month before the convention.”

This item will be moved to New Business. Five minute recess.

Business resumed.

Orrok started by explaining that we have a contingent donation of \$1500 available if all positions on the board are filled. Jeansonne offered to double this to \$3,000. Orrok described each of the positions up for election. He also advocated that each board member recruit program team leaders to handle the many tasks that can be associated with each position.

Platform Committee Report – David Jurist

Jurist proposed several additions to the party platform. He described the current political and fiscal situation. Fiscal Discipline was the first item proposed. It included the current platform and several additional points including a state owned bank.

PROPOSITION #1: FISCAL DISCIPLINE

All persons are entitled to keep the fruits of their labor. We call for the repeal of the income tax and the abolishment of programs and services not required under the Constitution. We oppose legal requirements forcing employers to serve as tax collectors. We discourage governments’ incurring debt, which burdens future generations without their consent. We support balanced public budgets, balanced by cutting expenditures rather than by raising taxes.

We favor free-market local banking, with unrestricted competition among banks and depository institutions of all types. Individuals engaged in voluntary exchange should be free to use as money any mutually agreeable commodity or item. We support a halt to inflationary monetary policies and unconstitutional legal tender laws. We advocate freedom from the reserve systems of offshore central banks.

We advocate the undertaking of monetary reform by the state’s institution of its own currency and credit, supported by tangible wealth existing within the boundaries of the state in the form of its mineral wealth, land, water, productive manufactures, and natural resources. We advocate the formation of a state-owned bank which extends grants to deserving, credit-worthy individuals and entities without usurious interest rates for repayment.

Mike Spalding moved, and Lance Haverkamp seconded, to move the Fiscal Discipline plank to committee. After a presentation by Orrok, it passed 18 to 6.

Jurist introduced proposition number 2, a requirement that we take the lead in rewriting Colorado’s water laws. Several members spoke against it.

PROPOSITION #2: WATER

We advocate undertaking the leadership of long-term evaluation and preparations for how to couch party principles and advocacy with regard to the measurement, collection, diversion, conveyance and conservation of water resources and water rights in the state of Colorado that will prepare us to serve the next three generations of state citizens, as the world population during the next twenty-five years is expected to rise to nine billion people.

Thomas Haupt moved, and Steve Gallant seconded, to refer this plank to committee. With no objection, it was referred to committee.

PROPOSITION #3: ENVIRONMENTAL RESPECT

We support a clean and healthy environment and sensible use of our natural resources. Private landowners and conservation groups have a vested interest in maintaining natural resources. Pollution and misuse of resources cause damage to our ecosystem. Protecting the environment requires a clear definition and enforcement of individual rights in resources like land, water, air, and wildlife. Free markets and property rights stimulate the technological innovations and behavioral changes required to protect our environment and ecosystems. We realize that our planet's climate is constantly changing, but environmental advocates and social pressure are the most effective means of changing public behavior.

While energy is needed to fuel a modern society, government should not be subsidizing any particular form of energy. We oppose all government control of energy pricing, allocation, and production. We advocate independence from manipulation of physical-energy markets by hostile foreign sovereigns. We encourage the development of renewable energy resources of every type that can localize energy production rather than centralizing it with foreign sovereigns or offshore multi-national entities.

Number 3: motion to refer to committee by Matt Hess, seconded by Susan Quilleash-Nelson; no objections.

Ralph Shnelvar moved to table the discussion of platform to later in the day; seconded by James Jeansonne; no objections.

Continued candidate discussion, changed Eric Price from HD 43 to SD 30.

PROPOSITION #4: ECONOMIC DEVELOPMENT

We support the right of free persons to associate or not associate in labor unions. We oppose government interference in bargaining, such as compulsory arbitration or imposing an obligation to bargain.

Libertarians want all members of society to have abundant opportunities to achieve economic success. A free and competitive market allocates resources in the most efficient manner. Each person has the right to offer goods and services to others on the free market. The only proper role of government in the economic realm is to protect property rights, adjudicate disputes, and provide a legal framework in which voluntary trade is protected. All efforts by government to redistribute wealth, or to control or manage trade, are improper in a free society.

We support the removal of impediments to free trade imposed by governments and by non-governmental organizations (NGO's) that lie outside the purview of the democratic electorate. We advocate the audit of and challenges to non-governmental, administrative entities that usurp lawful authority of democratically elected officials, such as implement treaties without oversight by the people of the United States; namely, the North American Free Trade Agreement (NAFTA), The Trans-Pacific Partnership (TPP), and The World Trade Organization (WTO). Political freedom and escape from tyranny demand that individuals not be unreasonably constrained by government in the crossing of political boundaries. Economic freedom allows movement of human and financial capital across national borders. However, we support limitations to the entry into the United States of foreign nationals who pose credible threats to security, health or property of American citizens.

We aspire to enjoy the blessings of prosperity for ourselves and our descendants. However, we encourage entrepreneurs in the private sector to drive job-formation in a dynamic economy by introducing new technology to growth markets supported by favorable capital financing, as opposed to expecting governments to undertake economic development with tax-supported incentives to private industry.

Ralph Shnelvar moved to strike “supported by favorable cap. Financing;”, seconded by Floyd Bilderback; removed by a vote of 20 to 4.

Motion to refer proposition number 4 to committee by Jon Adams, seconded by Judy Darcy, passed 22 to 3.

PROPOSITION #5: MENTAL HEALTH

We encourage and promote the preservation peace, health, and safety. We favor the personal responsibility of individuals, their families and local communities for encouraging one another to grow long-term in physical, mental and emotional health that respects oneself and others. We oppose the expropriation of the diagnosis of the mental competence of individuals by governments post facto, especially as regards the declaration of juveniles being “incompetent to proceed” within the criminal justice system.

Motions were made, and seconded, to insert “of” before “peace, health... ,“ and to insert “Ex” before “post facto”; both adopted unanimously.

Motion to refer number 5 to committee by Susan Quilleash-Nelson; seconded by Lynn Weitzel. Passed.

New Business:

3 free student passes resolution; Moved by Eva Kosinski, seconded by Ralph Shnelvar.

Amendment moved by James Jeansonne, seconded by Judy Darcy, amended to ‘some, by the board.’

Passes 20 to 1.

Resolution now reads: “In order to spur a greater interest in attending and participating in the state LP convention, I propose that the board set aside some number, to be decided by the board, of all-event convention passes to be given to voter registration-eligible students who apply, a drawing to be held the month before the convention.”

Business meeting adjourned.

BOARD REPORT

REGIONS

Amy Lunde-Provines, LPCO Regions Director, has been very busy trying to build Party presence in the state of Colorado. At the time of last year's Convention (March 2014), there were twelve county groups in all – five affiliates and seven development groups. The number currently stands at five affiliates and fifteen development groups. At this writing, there are eleven regions in the state, and LPCO will be concentrating on a region each month for eleven months of the year, looking for at least one contact in each county. Some regions have no contacts or organized groups in any of their counties, while the Metro region, with seven counties therein, has five groups – leaving only Adams and Broomfield counties without representation in that region at this time. It is Amy's goal to have at least one contact in each of the sixty-four counties by the end of her next term, should she be re-elected this year.

CAMPAIGNS

2014 was a great year for the many Libertarians who took on the challenge of running for public office. We had around forty Libertarians on ballots around the state, some of whom did very well in their races. More and more, our candidates are stepping up and running active campaigns. This is a great trend to follow, and we encourage future candidates to attend the seminars at this convention to learn how to embark upon a successful campaign for the 2016 elections!

OUTREACH

From People's Fair to PrideFest, from our affiliates' events to campaign events, over the last year, volunteers with the Libertarian Party of Colorado had opportunities to speak to hundreds of people about the philosophy of libertarianism. Plans are in place for LPCO to attend many organized events this year, starting in late spring and continuing through the summer. Stocked with new brochures, bumper stickers, door hangers, and other outreach materials (who can forget the World's Smallest Political Quiz?), we're ready to show people how they, more than likely, espouse the principles that the Libertarian Party holds dear. We ALWAYS need great volunteers like YOU to help out at the many outreach opportunities we attend. 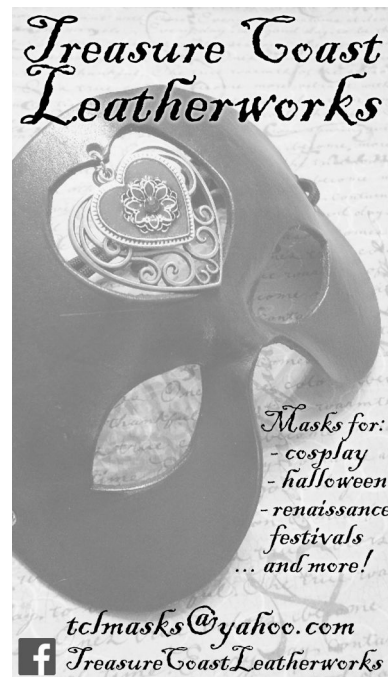
COMMUNICATIONS

Though only in the position of Legislative Director for a little over two months, Michael Stapleton has jumped right into the fray, and has been reviewing the legislative calendar and following bills weekly to look for opportunities to make the Libertarian argument in support of, or opposition to, legislation. He has been following Principles of Liberty as well as working with other citizen based lobby groups, and he has personally testified at the Capitol many times. As of April 9th, 263 bills have been presented in the Senate and 344 presented in the House, with many joint resolutions signifying special recognitions and memorials.

The 2015 legislative session, coming to a close on May 7th, has been a mixed bag – bills mandating the type of winter tire you must have to travel the I-70 mountain corridor, repeal of civil asset forfeiture, repeal of common core and PARCC assessment testing, Native American school mascots, and law enforcement reform. There have been several bills presented to repeal the 2013 anti gun legislation. Most have made it out of the Republican-controlled Senate with bipartisan support from a few Democrats, but end up being killed in the Democrat-controlled House Committees. Those bills that are presented initially the House to repeal anti gun legislation are killed in committee.

BOARD REPORT

This legislative cycle has been a learning experience for Mr. Stapleton, and going forward as Legislative Director for the Libertarian Party of Colorado, he plans to continue to be proactive in his efforts, encourage engagement by fellow Libertarians in the legislative process, inform Libertarians and the community on the actions of our elected representation, build relationships with the elected, citizen lobby groups, and gather intel from the legislative cycle that can be used to our benefit in the election cycle. Michael looks forward to continuing to serve the Libertarian Party of Colorado, fellow Libertarians, and those who share our philosophy of Individual Liberty, Limited Government, and Free Markets.

RECORDS

Our Records Director, Mike Spalding, created and corrected the minutes for the Libertarian Party of Colorado Board Meetings, and set up an off-site archive to protect these records. Mr. Spalding also was able to compile the minutes from the 2014 convention, taken by three different recorders at different points during the business meeting. During the summer of 2014, Mike, having formerly served as LPCO Treasurer for years prior, trained and transitioned Donna Price, the Treasurer elected at the last Convention, into that very important position. Mr. Spalding participated in several of the outreach events over the last year, and served as Treasurer for one of our statewide candidates. In addition to Board duties, he spent autumn of last year working to (successfully) stop the West Metro tax increase and to shepherd the Recall Elected Officials amendment.

TREASURY

After a rough patch following the 2014 Convention, we appear to be moving in a great direction this year! LPCO switched merchant service providers, and in the process, we're saving a very significant amount from the reduction in fees. Donna Price, with the help of her husband, Eric, has been making sure The Libertarian Party of Colorado has been keeping on top of finances and filing reports, on time, with the Secretary of State. Thanks to our wonderful donors and the efforts of our Fundraising Director, we've been able to continue our efforts with outreach, reaching new members, and maintaining our office space. Please consider joining the 1776 Club to help us reach more current and prospective members, and keep a roof over our heads, so to speak.

FUNDRAISING

Clint Jones, LPCO's Fundraising Director, has been very busy since being elected at the 2014 Convention. He called four hundred forty-one, and emailed a hundred, Libertarians who have contributed to the National LP in the last year, asking for financial support for the LPCO. From these calls and emails, the Libertarians contributed over \$1900 toward outreach to newly registered Libertarians. Clint also called thirty-seven current and past 1776 Club members who contribute monthly toward sustaining the LPCO. Of these thirty-seven, twenty-two give a total of \$552 in sustaining monthly contributions. A volunteer stuffed, stamped, and addressed three hundred letters to Libertarians registered in 2014, with a welcome letter, bumper sticker, and a door hanger. Mr. Jones called these new Libertarians to ask if they would place 100 door hangers in their neighborhood. Of the sixty-six who were able to be reached, fourteen said, "YES." With LPCO Board approval, designed and purchased 10,000 door hangers for \$968. Called volunteers from Board members to newly registered L's who placed almost 7000 door hangers and raised @\$200 toward the next batch of door hangers. Purchased 900 bumper stickers for \$180 and 1000 brochures for \$130 from the LP Store for use at outreach booths and outreach to 2015 newly registered Libertarians. Formed a plan with the Treasurer and Records Director to keep monthly contributions flowing by following up quickly with 1776 Club members whose credit cards expire or are declined. Your ideas, with your volunteering work supporting those ideas, are welcomed. Joining the 1776 Club, or making a one time contribution, is also greatly appreciated.

Today, Laura serves as a board member and legislative speaker for a cannabis council, is a criminal justice teacher at Westwood College, and is a background investigator for various police and fire departments.

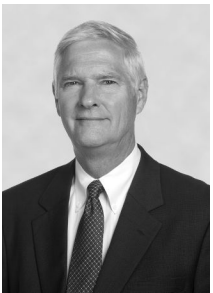

She is a very proactive member of the Sex Worker Nation which is currently galvanizing and organizing nationally, as well as internationally, to establish sex worker rights across the globe. She is a member of ESPU (Erotic Service Provider's Union) which has filed what many American-based sex workers hope will be a monumental case in behalf of everyone's sexual freedom – by challenging the Federal Government regarding the constitutionality of prostitution laws.

Elle has appeared in an episode of National Geographic Channel's "Taboo" series as an adult play facilitator – working from the philosophy that adults benefit from erotic and non erotic play as a stress reliever and therapeutic modality. She often lectures and educates on myriad topics pertaining to sex work as well as sex trafficking. Prior to her career as a BDSM professional, she worked in the Holistic Medicine Field for 18 years as an L.M.T. Elle is also an artist, writer, and avid researcher.



Judge James P. Gray is an American jurist and the 2012 Libertarian Party vice presidential nominee. He was the presiding judge of the Superior Court of Orange County, California. Gray was the 2004 Libertarian Party candidate for the United States Senate in California. He is the author of multiple books and a play, and is critical of current American drug laws.

Gray has been a member of the California Judicial Council, as well as the California Judicial Council's Advisory Committee on Juvenile Law, the Alcohol Advisory Board to the Orange County Board of Supervisors, the Advisory Board of the California Department of Alcohol and Drug Programs, and the Orange County Law Library. He has also been a member of the Board of Councilors of the USC Law School. Gray also introduced Orange County to the Peer Court system, where juvenile defendants travel to a school outside their district to have their actual cases tried by other teenagers.

He is the author of *Why Our Drug Laws Have Failed and What We Can Do About It – A Judicial Indictment of the War on Drugs* (2001), and is one of the 62 people featured in the 2007 documentary *American Drug War: The Last White Hope*.



Alan Hayman has a BFA in Media Arts for film production from the University of Arizona. He has directed, produced, edited and written short films and music videos, and is currently working on a documentary about geology. 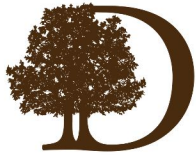

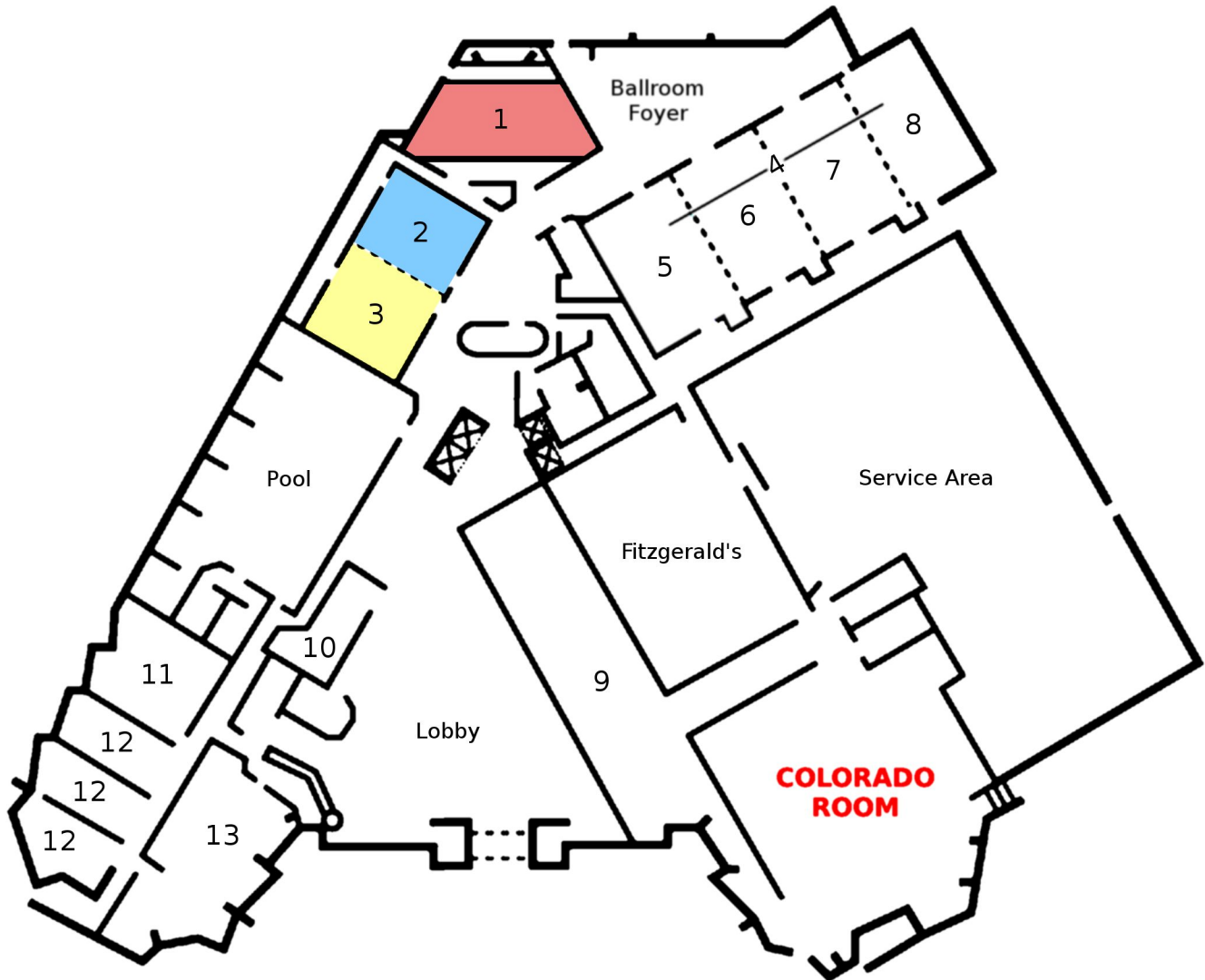
